## **Abstract / Purpose of the FAS Topic Paper:**

This FTP addresses the ambiguity that currently exists in DO-331/ED-218 Annex <u>Tables MB.A-3</u> Item #2, <u>MB.A-4</u> Item #1, <u>MB.C-3</u> Item #2, and <u>MB.C-4</u> Item #1. The current wording can be misinterpreted and hence oversimplify the use of simulation.

## **FTP Discussion:**

The current wording in the "Items" following DO-331/ED-218 Annex <u>Tables MB.A-3</u>, <u>MB.A-4</u>, <u>MB.C-3</u>, and <u>MB.C-4</u> could be misinterpreted when using simulation as a means of compliance. The intent of the "Item" notes is that referenced objectives are <u>additional</u> objectives to be met and not a replacement for the original objectives which contain the "Item" notes.

As an example, the "Item 2" note in Annex <u>Table MB.A-3</u> does not mean that if simulation cases, procedures and results are reviewed, then Annex <u>Table MB.A-3</u> objective 1 does not need to be satisfied. Rather, if simulation is used to satisfy Annex <u>Table MB.A-3</u> objective 1, review of the simulation cases, procedures and results should be performed and those reviews will need to ensure the simulation is fulfilling the original Annex <u>Table MB.A-3</u> objective 1.

Specifically, the following applies when simulation is used as a means of compliance:

- For Annex <u>Table MB.A-3</u> Item 2, objectives MB.8, MB.9, and MB.10 should be met in addition to objectives 1, 2, 4, and 7.
- For Annex <u>Table MB.A-4</u> Item 1, objectives MB.14, MB.15, and MB.16 should be met in addition to objectives 1, 2, 4, 7, 8, 9, and 11.
- For Annex <u>Table MB.C-3</u> Item 2, objectives MB.8, MB.9, and MB.10 should be met in addition to objectives 1, 2, 4, and 7.
- For Annex <u>Table MBC-4</u> Item 1, objectives MB.14, MB.15, and MB.16 should be met in addition to objectives 1, 2, 4, 7, 8, 9, and 11.
